Whereas, no business was conducted since the Corporation's effective date of March 3, 2014;



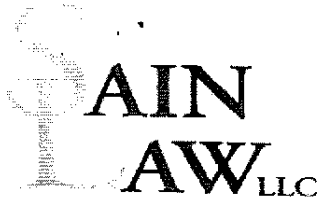
