Revised Concise Statement on behalf of Respondent No. 1 in relation to approximately 100,000 GB Pounds retained by Directors/Shareholders of NSL from the Sale of the London Flat

It is most respectfully submitted: THAT,

1. Respondent No. 1 had nothing to gain by not disclosing to the authorities in Pakistan and to this Honourable Court, the utilisation of approximately 100,000 GBP retained by the Directors/Shareholders of Niazi Services Limited.

The same was not taxable in Pakistan either.

The reply of the Respondent No.1 qua this issue was based on memory, lack of documents and information provided without supporting documents.

 Respondent No. 1 contested elections for a seat of the National Assembly in the elections held on October 2002 and remained a holder of Public Office till the expiry of the Constitutional term of that Assembly.

Respondent No. 1 did not contest the elections held in 2008 but was elected again in the elections held in 2013 and remains a holder of public office till date.

 In Pakistan, Respondent No. 1 had Bank Accounts in Al Falah Bank and Allied Bank. These were Pak Rupees, US Dollars, Euro and Sterling Pounds Accounts.

Respondent No. 1 had no Bank Account outside Pakistan after 2000.

- 690,307.79 GBP was received on 14.4.2003 as the net sale price of the London Flat in the accounts of NSL, controlled by the Shareholders and Directors of three companies.
- 5. Upon Respondent No. 1's written instructions dated 11.4.2003, GB Pounds 38,124.02 were remitted to T Nawaz and Co while 562,415.54 GBP were sent on 18.4.2003 to Ms Jemima Khan's account as refund of the money sent by her to Rashid Ali Khan and payment made by her to the Architect.

The receipt of this amount in her specified account has been confirmed with documents attached with CMA 6799/2017.

Original documents from Citi Bank of her remittances to Rashid Ali Khan have already been surrendered to the Court.

6. On **22.5.2003**, Ms Jemima Khan remitted **99,975** GBP into Respondent No. 1's Account No. 0035 – 02870474 maintained with Bank Al Falah.

Out of these, 79,000 GBP were officially converted into Pak Rupees on 26.5.2003 and duly reflected in returns to the ECP and FBR for the year ending 30.6.2003. The balance amount is also reflected in the returns submitted by Respondent No. 1. At that point in time the house in Bani Gala was being constructed.

- 7. The judgment in favour of the tenant in the London Flat (who had not paid rent since October 2001) was announced by the County Court on 25.6.2003 awarding 48,000 GBP with interest and cost.
 - a. It was to meet the Trial Court's judgment and related costs that approximately 100,000 GBP were retained by the Directors/Shareholders and which may well have exceeded the amount retained. Respondent No. 1 was informed that nothing out of the retained amount was receivable by him.
 - b. **25,000** GBP approximately was paid to the Solicitors representing NSL in the Appellate Court without reference to Respondent No. 1.
- 8. The Judgment of the Appellate Court (Page 14 to 17 of CMA 3657/2017) was delivered on 10.2.2004.
- 9. After the delivery of the judgment by the Appellate Court, a sum of **40,000** GBP was remitted by NSL to Respondent No. 1 on **17.5.2004**, which was not recalled earlier by Respondent No. 1 or his Tax Consultants.

This was received in the Account of Respondent No. 1 maintained with Al Falah Bank, converted into Rupees, declared to FBR and ECP and are reflected in the same.

This amount was not taxable in Pakistan.

- 10. Thereafter, litigation with the tenant continued by NSL without reference to Respondent No. 1 to recover unpaid rent and other costs.
- 11. The income tax authorities assessed the tax payable by Respondent No. 1 for the year ending **30.6.2003** (Page 26 to 29 of CMA 6512/2017).

All income tax returns have already been submitted to the Honourable Bench.

12. A settlement was reached with the tenant after litigation in Amsterdam and NSL was also operating Euro Account.

Respondent No. 1 received a total of Euros 42,456 from NSL in two tranches of 20,000 Euros and 22,456.70 Euros on 4.7.2007 and 4.3.2008 respectively. This too was converted officially into Pak Rupees and declared to the Tax Authorities.

A Bank Account in Euros had been operated by the Directors/Shareholders to receive payments by the former tenants in terms of the Settlement by their Solicitors.

The entire Bank Statements of NSL Euro Account is also attached.

They were not required to be declared to the ECP as Respondent No. 1 ceased to be a Member of National Assembly in October 2007.

13. The records of NSL available with the successor to Barclays Private Trust have now been received.

By 2012, nothing was receivable and the demand to give more money by Shareholders/Directors of NSL was refused.

To the best of the information of Respondent No. 1, NSL was de-notified in 2012 and its ghostly paper existence came to an end for non-filing of annual returns.

- The position earlier taken qua the remaining almost 100,000 GBP retained by NSL in 2003 was based on memory, incorrect advice, absence of the requisite record, lack of documentary information.
- 15. It is reiterated that any income from sale of the London Flat was not taxable in Pakistan and was dissipated. However, all and any amount remitted by Ms Jemima Khan or NSL were duly declared in Pakistan.

It is therefore, respectfully prayed that the permission may kindly be granted to bring on record the relevant documents and Revised Concise Statement.
