#### AGREEMENT

This Agreement made at Lahore this 4th day of May 1991 by and between Pepsicola International and Mr. Imran Khan withnesseth as follows:

- 1. Mr. Imran Khan shall be available for purposes of this Agreement during the period, May 1991 and August November each year or during such additional period as may be agreed by him in writing.
- 2. Mr. Imran Khan will conduct cricket coaching clinic for schools on behalf of Pepsicola International in different cities of Pakistan, namely Karachi, Lahore, Islamabad, Peshawar, Sargodha, Multan and Faisalabad.
- 3. Mr. Imran Khan will select and appoint coaches at his discretion for the above clinics.
- 4. Mr. Imran Khan will hold a Press Conference to innounce the launch of these clinics, where in he will give out details of the itinerary of the cricket clinics, and his association with Pepsi for the promotion of regional cricket.

- if. Invan Than will in person visit and formally inaugurate the origines coaching clinics at all the origines.
- 5. At the end of each session of the coaching clinic, Mr. Imran Khan will personally hand over certificates to all the participants at the various clinics.
- 7. At the end of each coaching session the respective coaches will hold a tournament amongst the participating schools for selection of the best team to appear in a tournament amongst the best team of the 7 centres.
- 3. There will be inter clinic tournament amongst the best teams of the 7 clinics to determine the champion. The final of this tournament will be held at Lahore.
- The cricket coaching clinic will be called "Pepsi Imran Cricket Promotion Clinics".
- 10. The cricket coaching clinics will be conducted from 1 March 31 August every year but Mr. Imran Khan's visits to such clinics shall only be during the period indicated in clause 1.
- 11. This Agreement between Pepsicola and Mr. Imran Khan will be valid for a period of three years and shall be renewable thereafter on such terms and conditions as are mutually agreed by both the parties.
- 12. Mr. Imran Khan will be paid a fee per annum during the period covered by this Agreement. This fee shall be:

1. First year Rs. 50,000/- 11. Second year Rs. 50,000/- 111. Third year Rs. 50,000/- 111.

This fee shall be paid on or by the 28th Februarvin each year prior to the commencement of Mr. Khan's services during the said year.

Pepsicola International shall also advance/reimburse all the expenses, at actuals, incurred by Mr. Imran Khan to meet his obligations such as on travel and hotels and meals during visits under this Agreement.

14. In case of default by either party in the preceding year, the aggrieved party shall have the right three (3) months prior to the commencement of Mr. Khan's services in a particular year to terminate this agreement. On such terminating, Pepsicola shall not use any literature, photographs, souvenirs, brochure, publicity materials, audio or visual, or both linking Mr. Imran Khan with Pepsicola International.

Interflow Communications shall represent Pepsicola International in the implementation of this Agreement and it is agreed that Interflow Communications shall have full authority for and on behalf of Pepsicola International to agree on the details of the implementation of this agreement.
